The Parish Council would like to welcome John Shaw and wish him well in his role of Parish Councillor.

Community Led Plan

Thank you to all residents who responded to the questionnaire that was delivered with December's Newsletter. From the response it was clear that residents agreed that a Community Led Plan was needed for the village. A Steering Group was created to oversee the development of the plan. A Community Consultation Event took place on Saturday 12th March; forty-two villagers attended the event. The Steering Group have created an action plan from the findings of the consultation to present to the Parish Council for adoption and for NE Lincs Council to approve. The CLP will be put on the Parish Council website. A hard copy will be with the Clerk.

Please see below key findings from the event: -

1. 59% of respondents are happy with (or accept) the new proposed boundary by North East Lincolnshire Council.
2. 87% of respondents consider building outside of this boundary to be unacceptable.
3. 84% of respondents highlighted concerns about the condition of the Public Rights of Way caused by horses (59%), Cycles (14%) and the general condition (27%).
4. Thoroughfare was identified as a local hotspot for blocked drains, flooding and fly tipping.
5. 85% of respondents stated that the speed limits in and around the village are adequate.
